If sentence was longer than three years the prohibition is for life; if three months or more but less than three years, the prohibition lasts for five years from the date of release. It is an offence for a person to transfer, let on hire, give or lend a firearm or ammunition to someone he knows or has reasonable grounds for believing to be prohibited by S21*
